2. That the Educational Institution shall serve the needs of the locality more particularly.

3. That the instructions shall adopt the curriculum and syllabus prescribed from time to time

4. The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.

5. That the qualified staff within the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the staff pattern.

6. That the results of the Institutions shall be satisfactory every year.

7. That the records /accounts shall be furnished to the D.E.O every year.

8. That the list of Governing Body shall be furnished to the D.E.O. every year.

9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.

10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.

11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.

12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.

13. That the society shall submit a proposal for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal of recognition.

14. The Recognition now given is purely on a temporary basis and is subject to the reports of the State Level Inspection and Vigilance Committee fulfilling all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.

16. The Management is requested to Renew the Vehicle Fitness Certificate every year from the concerned authorities without fail and submits the same to the concerned Deputy Educational Officer.

17. The management should improve the strength and maintain minimum economic strength as per the rules. Further, the management should obtain NOC from the Traffic Police, Structural Soundness Certificate and Sanitary Certificate from the competent authority every year and submit the same to the District Educational Officer, Guntur through the Deputy Educational Officer concerned.

Further, the managing committee of the school is requested to fulfill all requirements to cope with the needs of the institution at the latest before submitting of application for Renewal of Recognition for the year 2025-2026.

- 7) That the records / accounts, annual administrative report along with the audited accounts should be submitted to the District Educational Officer, every year.
- 8) That the list of Governing Body shall be furnished to the D.E.O., every year.
- 9) That the pay structure / fee structure fixed by the Governing body shall be submitted to the District Educational officer every year.
- (10)That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.
- (11)That the school shall not be closed without giving notice both to the parents / Dist.Ednl,Officer, and the competent authority at least 6 months before.
- (12) That the school shall be closed (or) permitted to be closed only from the date on which summer vacation is declared.
- (13) That the society shall submit proposals for renewal of Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of recognition.
- (14) The school management is requested to submit an affidavit every year with regard to non violation of rules / regulations prescribed by the Government from time to time.
- (15) The management is requested to submit renewal Structural Soundness Certificate and NOC issued by the Fire Service Department before expiry of certificates validity to this office every then only further ETR will be granted without proposals.
